GLAMIS ANNOUNCES RELEASE DATE OF THIRD QUARTER, 2003 RESULTS AND CONFERENCE CALL

October 28, 2003 Reno, Nevada -- Glamis Gold Ltd. (NYSE: GLG; TSX: GLG) will release its third quarter 2003 results before markets open on November 3, 2003. Following the earnings release, Kevin McArthur, President and Chief Executive Officer of the Company, will host a conference call at 12:00 noon PST (3:00 pm EST) on November 3, 2003 to discuss the latest operating and financial results, provide a brief update of the Company's development projects in Mexico and Guatemala and comment on recent exploration results at its Marigold mine in Nevada.
