Shareholders of record at the close of business on Monday, July 19, 2004 will be entitled to receive payment of this dividend on Friday, July 30, 2004. Goldcorp intends to make twelve (12) monthly payments of \$0.015 per share in 2004 for a total annual dividend payment of \$0.18 per share.
